#### The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 1000 Hillswood Drive, Chertsey, Surrey, KT16 OPS (the "**Promoter**").

#### **Promotion Period**

- 2. The Promotion will commence at 00:01 (GMT) on the 4<sup>th</sup> December 2019 and shall close at 23:59 (GMT) on the 25<sup>th</sup> December 2019, subject to the following exceptions:
  - I. Promotion Products from Carphone Warehouse must be purchased between 00:01 (GMT) on the 3 December 2019 and 23:59 (GMT) on the 25 December 2019.
  - II. Promotion Products from Vodafone Ireland must be purchased between 00:01 (GMT) on the 3 December 2019 and 25:59 (GMT) on the 25 December 2019. (the "Promotion Period")

- 7. Purchases from auction websites (e.g. eBay) or from third party sellers on online retailers' websites (e.g. Amazon Marketplace) are specifically excluded from this Promotion.
- 8. Rewards are non-transferable and there is no cash alternative. In the event of unforeseen circumstances, the Promoter may substitute a Reward of equal or greater value for the Reward. #### Claims

- 9.
