

**GENERAL TERMS AND CONDITIONS**  
**FOR**  
**HUAWEI MUSIC 6-MONTH FREE CAMPAIGN IN UK**  
**(THE “CAMPAIGN”)**

**1. Binding Terms and Conditions**

By taking part in the Campaign, you agree to accept and to be legally bound by these Terms and Conditions.

**2. Campaign Organiser**

This Campaign is organised by Aspiegel Limited (“**Aspiegel**”), a company incorporated in Ireland with its registered address at: First Floor, Simmonscourt House, Simmonscourt Road, Dublin 4, D04 W9H6, Ireland. Aspiegel is a wholly owned subsidiary of the Huawei group of companies.

**3. Territory for Campaign**

**4. Duration of Campaign**

The Campaign is valid from 3<sup>rd</sup> June 2020, and ends on 31<sup>st</sup> August 2020.

**5. Eligibility for Participation**

4.1 To be eligible to participate in the Campaign you must be aged 18 or over and residing in the UK. If you are under the age of 18 years old, you must obtain the consent of your parent or guardian or somebody who has legal parental responsibility over you.

4.2 In order to qualify for the Campaign, you must own a qualifying smartphone (see list in clause 6) with an EMUI software version of EMUI 4.0 or above, and have not previously claimed any free trial of HUAWEI MUSIC.

4.3 To participate, you must also have a HUAWEI ID with valid billing details and follow the below steps:

- b) Click on the dedicated banner or splash screen within the HUAWEI MUSIC app or HUAWEI MEMBERSHIP CENTER in order to obtain the 6-MONTHS FREE TRIAL;
- c) Click on “CLAIM NOW” to claim the 6-MONTH FREE TRIAL;
- d) Participants will be able check to see if the 6-MONTHS FREE TRIAL has been activated by visiting HUAWEI MUSIC app > Me > VIP Center>Membership.
